Mr. Gordon V.R. Holness has been working as a consulting engineer for 50 years and is Chairman Emeritus of Albert Kahn Associates, Inc. Architects and Engineers in Detroit Michigan. He is a registered professional engineer in 42 states and four provinces and a chartered engineer in the U.K. Mr. Holness is a ASHRAE Distinguished Lecturer and is currently serving as the ASHRAE President. He is a recipient of ASHRAE's Distinguished and Exceptional Service Awards, and has chaired many Society committees including the Professional Development Committee including serving as the ASHRAE representative on the advanced Energy Design Guide Steering Committee and the building SMART Alliance. He also published numerous articles and papers in US and Canada Journal on topics related to various aspects of Engineering Design Technology.

Program Highlight:

This seminar will discuss the development of ASHRAE's Building EQ or Energy Quotient program and the important role that building energy labeling can play in meeting ASHRAE's Sustainability Goals.

The seminar will address our approach in developing the program and the objective of providing building owners with specific information on the performance of their buildings relative to similar buildings in the same climate zone. It will identify the three major aspects of the program – the Asset or "as designed" Rating, the "Operational Rating" and the underlying "Technical Data" supporting these ratings.

In addition the presentation will identify current ASHRAE education and certification programs being developed to support Building EQ
