Programme Highlights

The European Union (EU) Directive on Energy Performance of Buildings is an important policy that will greatly affect awareness and promotion of energy efficiency in buildings. By enhancing the legislation and market forces, the policy intends to remove the barriers to improving energy performance of buildings and will lead to substantial increases in investments in energy efficiency measures. This technical talk will explain the background of the EU Directive, evaluate its characteristics and rationale, highlight the critical issues and discuss the possible implications to our society. Practical experience, key factors and requirements in the actual implementation will be described. The EU experience is useful to Hong Kong in developing building energy codes and measures to promote energy efficiency.

Speaker

Ir Dr. Hui is a Teaching Consultant and an Honorary Assistant Professor of the Department of Mechanical Engineering, The University of Hong Kong. He has a strong technical background in the study of energy efficiency in buildings and is active in promoting building energy and environmental research that integrates architectural design and sustainable building technology. He has acted as a visiting fellow to research institutes in Japan, Germany and USA. He has also acted as a Technical Expert in building energy code and green building assessment projects in Hong Kong, Mainland China and Thailand. He was the President of the ASHRAE (American Society of Heating, Refrigerating and Air-Conditioning Engineers) Hong Kong Chapter in 2006-2007.
