## **Programme Highlights**

The Hong Kong Government is committed to develop Renewable Energy, which contribute 1-2% of Hong Kong's total electricity supply by 2012. Wind turbine is ranked as first priority for the development of the China renewable energy plan. As wind turbine & wind farms are often installed in open area, where wind turbines are frequently placed at locations highly exposed to lightning strokes.

The complicated electronic & electrical control systems are exposed to the threat of lightning and its surge voltage. The guide lines of design on lightning protection for wind turbine are given in IEC standard of IEC TR 61400-24 & IEC 62305. The principles of this new standard will be introduced and some installation samples will be given. It helps engineers in handling the basic concept to design and lightning protection system for the electronic equipment and building structure of the wind turbine.

### Speaker

**Mr. Henry Lau** is an experienced electrical engineer working in the field of over-voltage protection on low voltage system for over 10 years. He has been trained in various factories in England and Germany. He also participated in the drafting of the China Telecom Over-voltage Protection Standard. Now, he is working with Germany BET Testing Laboratory for the testing of over-voltage protection devices.
